INTRODUCTION

This Cookies Policy ("Policy") explains how Yok-AI ("we," "us," "our") uses cookies and similar technologies on our website (www.yok-ai.com) and related online services. This Policy provides you with information about what cookies are, what cookies we use, and how you can control cookies.

WHAT ARE COOKIES?

Cookies are small text files that are stored on your device (computer, tablet, smartphone) when you visit certain websites. Cookies are widely used to make websites work more efficiently, provide a better browsing experience, and provide information to the owners of the site.

Cookies may be set by our website directly ("first-party cookies") or by third parties providing services to us ("third-party cookies"). They may be session cookies (which expire when you close your browser) or persistent cookies (which remain on your device for a set period or until you delete them).

TYPES OF COOKIES WE USE

We use the following categories of cookies on our website:

1. Essential Cookies

These cookies are necessary for the website to function properly and cannot be switched off in our systems. They are usually only set in response to actions made by you which amount to a request for services, such as setting your privacy preferences, logging in, or filling in forms. You can set your browser to block or alert you about these cookies, but some parts of the site will not function properly if these cookies are blocked.

Examples of essential cookies we use:

- Session cookies that manage your active session
- Authentication cookies that identify you once you've logged in

Security cookies that enable security features and detect malicious activity

2. Functional Cookies

These cookies enable the website to provide enhanced functionality and personalization. They may be set by us or by third-party providers whose services we've added to our pages. If you do not allow these cookies, some or all of these services may not function properly.

Examples of functional cookies we use:

- Cookies that remember your preferences (such as language or region)
- Cookies that remember information you've entered or choices you've made
- Cookies that provide customized content

3. Analytics Cookies

These cookies allow us to count visits and traffic sources so we can measure and improve the performance of our site. They help us to know which pages are the most and least popular and see how visitors move around the site. If you do not allow these cookies, we will not know when you have visited our site and will not be able to monitor its performance.

We use Google Analytics which sets cookies to help us analyze how users use the site.

4. Marketing Cookies

These cookies may be set through our site by our advertising partners. They may be used by those companies to build a profile of your interests and show you relevant advertisements on other sites. They do not directly store personal information but are based on uniquely identifying your browser and internet device. If you do not allow these cookies, you will experience less targeted advertising.

We use cookies for various purposes, including:

- Remembering your preferences and settings
- Authentication and security
